ORDER REGARDING APPLICATION FOR ADMISSION

This matter is before the Court on Attorney Kenneth Moll's application for admission to practice in the Western District of Michigan. The Chief Judge referred this matter to the undersigned three-judge panel on June 16, 2022. (Administrative Order No. 22-AD-048).

Given a number of concerns regarding prior sanctions and suspensions of his law license, the panel directed Mr. Moll to provide supplemental information in response to a series of questions posed by the Court. He provided his response to those questions on June 29, 2022. On September 14, 2022, Mr. Moll provided a supplemental response, notifying this Court that his application for admission to another district court had recently been denied.

On September 15, 2022, the undersigned judicial panel conducted a hearing on the record, at which Mr. Moll testified under oath. Having carefully considered Mr. Moll's oral and written submissions, and giving Mr. Moll the benefit of the doubt, the panel unanimously has decided to admit Mr. Moll to practice in the Western District of Michigan. Nevertheless, and due to the Court's continued concerns regarding Mr. Moll's prior disciplinary record, he shall be admitted in a probationary status.

Accordingly,

IT IS ORDERED that Mr. Moll's application for admission to practice in the Western District of Michigan is GRANTED, subject to the following:

IT IS FURTHER ORDERED that Mr. Moll shall serve a three-year term of probation, subject to the following conditions:

- 1. Mr. Moll shall complete no less than three hours of CLE credit relating to professional ethics by no later than December 31, 2022, and file an affidavit of compliance with the Court by no later than January 15, 2023;
- 2. Mr. Moll shall engage a mentor who has been admitted to practice in the Western District of Michigan for at least five years, and who has remained in good standing throughout his or her tenure of admission;
- 3. Mr. Moll shall file with the Clerk of Court by no later than November 30, 2022 an affidavit from his mentor outlining his or her plans to assist Mr. Moll in his professional development; and
- 4. Mr. Moll shall not violate any rule or court order that results in any sanction by a judicial officer of this Court.

Violation of any of the terms of probation will result in Mr. Moll's summary revocation of his admission to practice in this district, and he will have no right to appeal that decision. The undersigned judicial panel shall retain jurisdiction over this matter during the period of Mr. Moll's probationary period.
