Directions and Accommodations

Jurors summonsed to the Marquette office of the U.S. District Court, Western District of Michigan are selected from the following counties: Alger, Baraga, Chippewa, Delta, Dickinson, Gogebic, Houghton, Iron, Keweenaw, Luce, Mackinac, Marquette, Menominee, Ontonagon, and Schoolcraft.

When can I check my reporting instructions?

Reporting instructions are available online via eJuror or by phone after 12:00 noon, one business day prior to the date listed on your summons. If your summons date falls on a Monday, you may check the preceding Friday or throughout the weekend. **To determine whether to report for jury duty, you will need your nine digit participant number which is printed above your name and address on your summons form.**

Where do I go?

The U.S. District Court is located at 202 W. Washington St., Marquette, MI 49855. You will report to the Clerk's Office (#229). Please note, the building opens at 7:30 a.m. In the event of an emergency, you can call (906) 226-2021 during regular business hours. Reporting instructions are not available at this number.

Where can I park?

Free parking is available on the Upper Level of the Bluff St. Parking Ramp (the section that does not have a cover). The reverse side of this page serves as your parking permit - please be sure to put the parking permit in your window. If you do not park on the Upper Level, you will be subject to parking violations/tickets. Do not park at a parking meter as you will not have time to leave to pay meter charges. The Court is not responsible for any parking violations.

Can I stay overnight?

Jurors residing over seventy-five (75) miles from the courthouse during April-October or fifty (50) miles during November-March qualify to be reimbursed \$140.00 per day, in addition to daily attendance fees. This is intended to cover hotel and meal expenses. Any expenses above this amount will not be reimbursed by the government. A hotel receipt is required for reimbursement. Jurors who elect to stay with family/friends will be reimbursed \$51.00 per day.

Following are some area hotels. This list is for your convenience only and does not represent all available hotels. There is no affiliation between the government and these hotels. You are free to stay wherever you would like, but you will only be reimbursed as indicated in the paragraph above. Always ask for the federal government rate when making reservations. Most hotels limit the number of rooms offered at the government rate, depending upon availability.

(for Bluff St. ramp only; for jury duty only)





Parking

Parking is available on the Upper Level of the Bluff Street Parking Ramp (place this in your window as your parking permit).



Driving Directions (U.S. District Court, 202 W. Washington, St., Marquette, MI 49855)

From the **West**: Follow M-28 E. to US-41 E. Follow US-41 E to US-41 BR South / Front St.; turn LEFT onto W. Washington St./US-41 BR. The courthouse will be on the right, on the corner of W. Washington St. and N. 3rd St. For parking, turn RIGHT onto N. 3rd St. Take the first RIGHT onto W. Bluff St. and the parking ramp will be on your right.

From the **South**: Follow US-41 N to US-41 W; follow US-41 W to US-41 BR South / Front St.; turn LEFT onto W. Washington St./US-41 BR. The courthouse will be on the right, on the corner of W. Washington St. and N. 3rd St. For parking, turn RIGHT onto N. 3rd St. Take the first RIGHT onto W. Bluff St. and the parking ramp will be on your right.

Alternatively, Follow M-95 north to US-41 E; follow US-41 E to US-41 BR South / Front St.; turn LEFT onto W. Washington St./US-41 BR. The courthouse will be on the right, on the corner of W. Washington St. and N. 3rd St. For parking, turn RIGHT onto N. 3rd St. Take the first RIGHT onto W. Bluff St. and the parking ramp will be on your right.

From the **EAST**: Follow M-28 West to US-41 W to US-41 BR South / Front St.; turn LEFT onto W. Washington St./US-41 BR. The courthouse will be on the right, on the corner of W. Washington St. and N. 3rd St. For parking, turn RIGHT onto N. 3rd St. Take the first RIGHT onto W. Bluff St. and the parking ramp will be on your right.
