ORDER SUSPENDING ATTORNEY TIMOTHY DAVID VANDENBERG

By letter and Notice dated May 10, 2019, the United States Trustee for Region 9 advised this Court that Attorney Timothy David VandenBerg 1) was suspended from the Michigan State Bar for non-payment of dues on May 3, 2019; and 2) has been facing criminal charges in State Court for forgery with trial set for June of 2019. A copy of the United States Trustee's letter and Notice is attached as Exhibit 1. Attorney VandenBerg did not self-report either of these things despite the requirement of Local General Rule 2.3(b)(i) and (c) that he do so.

This Court ordinarily imposes reciprocal discipline on members of the bar of this Court, which would mean that Attorney VandenBerg's suspension from the State Bar would automatically result in his suspension from the bar of this Court. Local General Rule 2.3(b)(ii). However, since 2016, this Court has not been applying automatic reciprocal discipline for State Bar suspensions premised "solely" on non-payment of dues. *See, e.g.,* Administrative Order 19-AD-030 (regarding March 2019 suspensions "solely" for non-payment of dues). In this case, however, there is more than simply a suspension for non-payment of dues at stake, and so the Court is electing to let the automatic suspension stand under Local General Rule (b)(ii).

Moreover, even apart from automatic reciprocal discipline, the undersigned finds good cause under Local General Rule 2.3(d) for immediate suspension of Attorney Timothy David VandenBerg. First, Attorney VandenBerg has failed to self-report to this Court two significant events he was obligated to report under the Local Rules. The criminal charge of forgery, which

published reports date to October of 2018, is disturbing all by itself because the alleged forgery

involved court documents. But the unresolved criminal charge is even more concerning because

of the failure to report, a direct violation of Local General Rule 2.3(c). Second, Attorney

VandenBerg also failed to report his State Bar Suspension, which he was obligated to do under

Local General Rule 2.3(b)(i), even if the basis for suspension was non-payment of dues. Finally,

a Chapter 7 bankruptcy trustee has already found cause to replace Attorney VandenBerg as special

counsel on a pending bankruptcy matter, as reported by the United States Trustee.

Accordingly, under both Local General Rule 2.3(b)(ii), and Local General Rule 2.3(d),

Attorney Timothy David VandenBerg is SUSPENDED, effective immediately, from the bar of

this Court and from practice before any Judicial Officer in any federal court in this

District. Attorney Timothy David VandenBerg may file a challenge to reciprocal discipline, or

seek reinstatement, as provided in Local General Rule 2.3(b)(iii) and (v). Attorney Timothy David

VandenBerg may also seek a three-judge hearing under Local General Rule 2.3(d) by filing a

request within the same time limit specified in Local General Rule 2.3(b)(iii) for challenge to

reciprocal discipline.

NOTICE BY THE UNITED STATES TRUSTEE UNDER W.D. MICH. L CIV R 2.3 OF BAR LICENSE SUSPENSION AND PENDING CRIMINAL CHARGES AGAINST ATTORNEY TIMOTHY DAVID VANDENBERG

Daniel M. McDermott, United States Trustee for Region 9 (Michigan/Ohio), pursuant to his authority under 11 U.S.C. § 307 and 28 U.S.C. § 586(a)(3), provides notice to this honorable Court under LCivR 2.3 of both the suspension of attorney Timothy David VandenBerg ("Mr. VandenBerg") by the State Bar of Michigan and pending criminal charges for forgery against him in Kent County's 17th Judicial Circuit Court. In support of this Notice, the United States Trustee states as follows:

1. Pursuant to 28 U.S.C. § 586, the United States Trustee is charged with the administrative oversight of cases commenced pursuant to Title 11 of the United States

Bankruptcy Code.1

¹ This duty is part of the United States Trustee's overarching responsibility to enforce the bankruptcy laws as written by Congress and interpreted by the courts. See, United States Trustee v. Columbia Gas Sys., Inc., (In re Columbia Gas Sys., Inc.), 33 F.3d 294, 295-6 (3d Cir. 1994) (noting that the United States Trustee has "public interest standing" under 11 U.S.C. § 307, which goes beyond mere pecuniary interest); Morgenstern v. Revco D.S.,

- 2. The United States Trustee Program is a component of the Department of Justice responsible for supervising the administration of bankruptcy cases and private trustees under title 11 of the United States Code. In our oversight role, we became aware of the suspension of attorney Timothy David VandenBerg's license to practice law and of pending criminal charges for forgery brought against Mr. VandenBerg in state court. To the extent these matters have not been previously self-reported by Mr. VandenBerg under LCivR 2.3(b)(1) or (c), or otherwise considered by the Court, the U.S. Trustee brings these matters to your attention for investigation and possible disciplinary action under LCivR 2.3.
- 3. Mr. VandenBerg is an attorney who was licensed to practice in the state of Michigan under license number P55960. Upon information and belief, his most recent business addresses were: 770 Kenmoor Ave. SE, Grand Rapids, MI 49546; 2627 E. Beltline Ave. SE, Suite 310, Grand Rapids, MI 49546; and 2401 Camelot Ct. SE, Suite M, Grand Rapids, MI 49546-6083. Upon information and belief, Mr. VandenBerg currently resides at 2214 Glenn Canyon Dr. SE, Caledonia, MI 49316.
- 4. Upon information and belief, Mr. VandenBerg's most recent involvement with the U.S. Bankruptcy Court for the Western District of Michigan was serving as special counsel for the Chapter 7 Trustee in the bankruptcy case of *David and Carole Settle* (GK15-02727) during the period 2016 through 2018. The Chapter 7 Trustee has since replaced Mr. VandenBerg with substitute counsel.

Inc., (In re Revco D.S., Inc.), 898 F.2d 498, 500 (6th Cir. 1990) (describing the United States Trustee as a "watchdog"). See also, H.R. Rep. No. 95-595, at 4, 88 (1977), reprinted in 1978 U.S.C.C.A.N. 5963, 5966, 6049; see also, e.g., In re South Beach Secs., 606 F.3d 366, 370, 371 (7th Cir. 2010); Curry v. Castillo (In re Castillo), 297 F.3d 940, 951 (9th Cir. 2002); In re Charges of Unprofessional Conduct 99-37 v. Stuart, 249 F.3d 821, 824 (8th Cir. 2001); A-1 Trash Pickup v. U. S. Trustee (In re A-1 Trash Pickup), 802 F.2d 774, 776 (4th Cir. 1986).

- 5. Effective February 15, 2019, the Michigan State Bar suspended Mr. VandenBerg from the practice of law in the state of Michigan for non-payment of bar dues. (*See* attached Exhibit A: "State Bar of Michigan Notice of Suspension for Non-Payment of Dues," a report dated May 3, 2019; and Exhibit B: a copy of the State Bar of Michigan member profile query.)
- 6. Additionally, Mr. VandenBerg has been charged with criminal forgery of court documents under MCL 750.248 in *State of Michigan v. Timothy David VandenBerg* (Case No. 18-10693). The jury trial for this case in the 17th Judicial Circuit Court has been rescheduled for June 10, 2019, before Judge Benson.
- 7. LCivR 2.3, entitled "Attorney Discipline," under sub-heading (a)(i) "Discipline Generally" states in pertinent part as follows:
 - (a) Any attorney practicing before the court is subject to discipline by the court upon a showing that the attorney is: (i) currently . . . suspended . . . by any admitting or licensing authority;
- LCivR 2.3 under sub-heading (c) "Criminal charges" states as follows:
 - (c) Upon being charged with a crime, the attorney must inform the clerk of court, in writing, of charges within 10 days of receiving notice of the charges.
