Administrative Order No. <u>21-MS-042</u>

In accordance with Local Civil Rule 73, and to promote judicial economy in conformity with the procedures in 28 U.S. C. § 636(c), the District Judges have unanimously adopted the following procedures for all prisoner civil rights and state habeas actions filed on and after July 1, 2021.

Promptly after a prisoner civil rights complaint or a petition for writ of habeas corpus is filed, the Clerk shall issue a notice to the plaintiff/petitioner, substantially complying with Attachment 1A (for a civil rights plaintiff) or 1B (for a state habeas corpus petitioner) to this order. The notice will inform the plaintiff/petitioner of their option to consent to the dispositive jurisdiction of a magistrate judge and will provide a statement for their use in exercising this option.

After the complaint or petition for writ of habeas corpus is served, the Clerk shall issue a notice to the defendants/respondent, substantially complying with Attachment 2A to this order. If the plaintiff has not previously consented to the dispositive jurisdiction of a magistrate judge, and after the complaint or petition for writ of habeas corpus is served, the Clerk shall issue a notice to the parties, substantially complying with Attachment 2B to this order.

If any party does not consent to the dispositive jurisdiction of a magistrate judge within 21 days of the Clerk's issuance of the notice, the Clerk shall assign the case at random to a district judge without necessity of any further direction from the Court; the case will be automatically referred to the originally assigned magistrate judge for the issuance of a report and recommendation.

The magistrate judge already assigned to this case would continue to decide all pretrial matters and would handle all dispositive motions by report and recommendation.
