This request will be competitively bid among several vendors. IMPORTANT: This is a request for quote (RFQ). Late quotes will not be considered unless the judiciary determines, at its own discretion, that considering the late quote is in the judiciary's best interest and will not unduly delay the procurement. STATEMENT OF WORK

INTRODUCTION:	The United States District Court for the Western District of Michigan is seeking pricing for upgrades to Judge Maloney's Jury Deliberation Room in Kalamazoo, Michigan.
INSTALLATION:	1st floor of the Kalamazoo Federal Building and Courthouse, 410 W Michigan Ave., Kalamazoo, MI 49007 - Work will be required during normal business hours and shall be coordinated with the Court. - Contractor will have access to a loading dock.
PARTIES	<u>Contractor</u>. The "contractor" includes the contractor, the contractor's employees, any subcontractor/supplier, or subcontractor's/supplier's employees who provide services to the court on behalf of the contractor at a specified price. <u>Court</u>. The "court" includes one or all of the following judicial agencies of the United States District Court for the Western District of Michigan: the district court clerk's office, the pretrial services office, and the probation office. Court projects may also include shared projects between the district court agencies and the bankruptcy court. <u>General Services Administration (GSA)</u>. GSA is an independent federal government agency that leases space to other federal government agencies, including the court.
SCOPE OF WORK:	- The contractor shall furnish all labor, equipment, tools, materials, and supervision necessary to perform all work in strict accordance with this Scope of Work as indicated below. The purpose of this project is to upgrade the Jury Deliberation Room within Judge Maloney's Chambers as described in the attached drawings and in compliance with the scope of work below. - The contractor will be responsible for the removal and disposal of cabinets, hardware, countertop, faucet, sink, wallpaper, carpet, base, and other galley components. - The contractor to provide and install new a new galley consisting of wood cabinets, crown molding, quartz counter top (Premier Group A), cabinet hardware, tile backsplash, and other necessary components. The contractor will provide any supports necessary to hang the new cabinets. - The contractor will provide and install new subway tile backsplash from top of new counter to underside of upper cabinets. Provide a range of tile samples for customer selection.

The contractor shall provide samples for final selection. • The contractor will remove old carpet and base and prep the floor for new broadloom carpet and carpet base. • The contractor shall install new carpet and 4" carpet base (both (J&J Flooring, Craftwork 6699, 2206 Glassblower). The padding shall be a Tred Mor, item #2568 and 68oz. • The contractor will be required to move the furnishings out of the space and re-install once the project is complete. A storage place for the furnishings will be provided in the basement of the building. An elevator is available between the basement and first floor. • After the wallpaper is fully removed, the contractor will patch, prepare and paint walls as required to provide a uniform, smooth finish free from visually discernable defects; contractor shall prime and paint walls as described herein. • The contractor shall paint a minimum of two coats of paint to completely cover the walls and shall use a low odor, interior, durable, commercial-grade washable paint. • The contractor shall provide <u>separate</u> pricing to replace the flooring and paint in each of the attached restrooms. The walls shall be patched and prepared to provide a uniform and smooth finish free from visually discernable defects. While a cabinet layout has been provided, the contractor must compare with field measurements to ensure the cabinets will fit. If any changes are required, a submittal must be reviewed and approved by the Court.

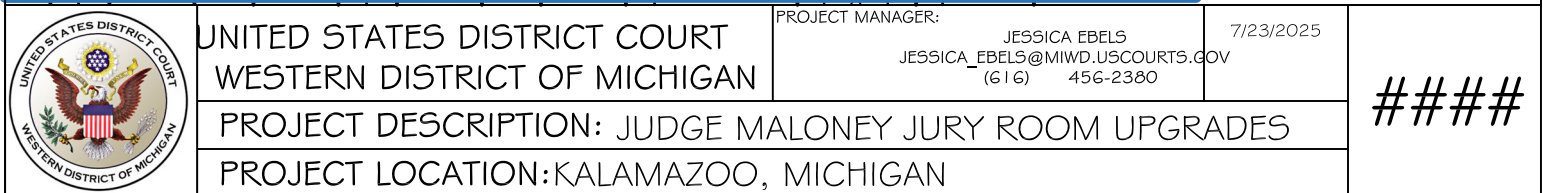

Contractor Criminal Background Guidelines

Purpose

To ensure the safety and security of all individuals within our facility, these guidelines establish clear requirements regarding the criminal background of contractors and their employees before they are granted access to our building.

Guidelines

Prohibited Offenses

Any individual with a criminal history with convictions or pending cases involving assaultive or violent crimes will not be permitted to work on Delegation of Authority Projects for the Western District of Michigan under any circumstances. This includes, but is not limited to:

- Assault (simple, aggravated, or felony assault)
- Domestic violence
- Robbery
- Homicide or Manslaughter
- Kidnapping
- Sex Offenses
- Any other offense classified as a violent crime under federal or state law

Additional prohibited offenses include any convictions or pending cases occurring in the United States District Court for the Western District of Michigan.

Reporting Obligations

Contractors must immediately report any criminal charges (that involve assaultive or violent behavior) filed against any of their employees assigned to the project. Failure to report such incidents may result in removal from the project and further contractual consequences.

Contract Termination

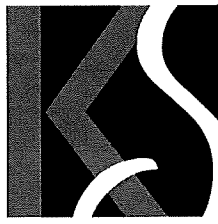
If it is discovered that an individual with a prohibited criminal history is working on the Delegation of Authority project, the contractor may be subject to contract termination.

Exceptions

Any requests for exceptions to this policy must be submitted in writing for review by the responsible agency within the Western District of Michigan. Such exceptions will be considered on a case-by-case basis and are not guaranteed.

Enforcement & Consequences

Non-compliance with these guidelines may result in immediate termination of access privileges, contract termination, and/or permanent removal from consideration for any future Delegation of Authority Projects for the Western District of Michigan.

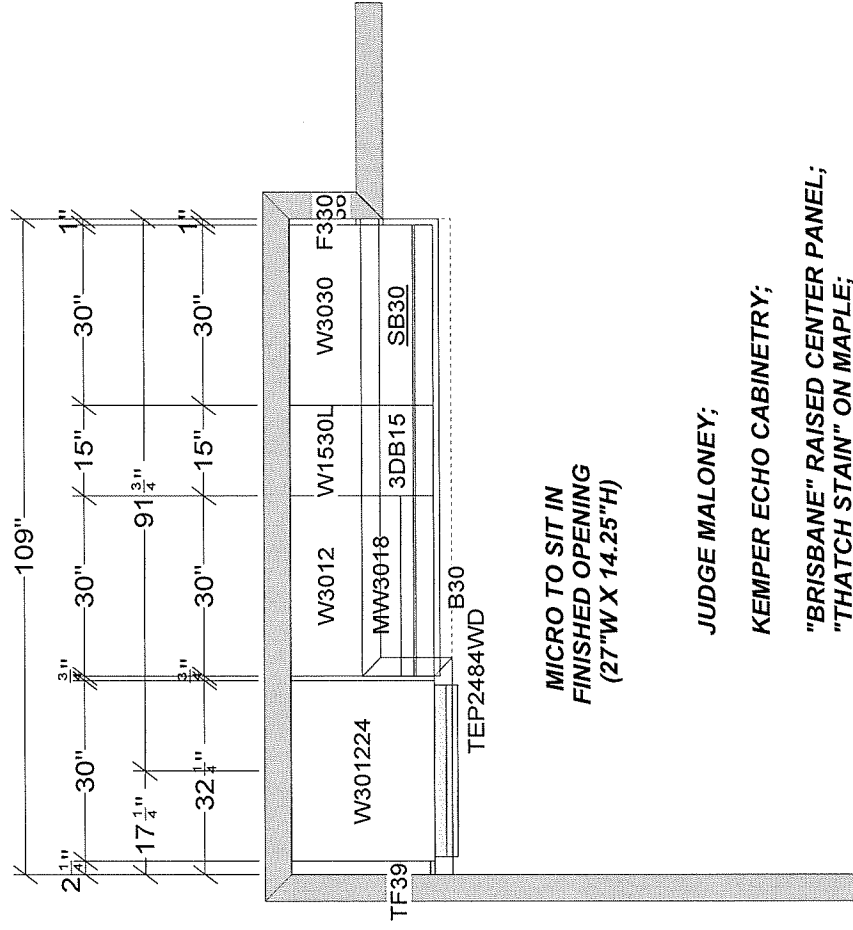

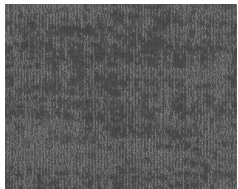
